The candidates appearing for the above examinations should fill Examination Application Forms carefully and enclose Xerox Copies of Memorandum of Marks of earlier examinations duly attested by the Principal of the concerned Colleges for ready reference, failing which the forms will not be accepted. Xerox Copies of Examination Application Forms & photographs will not be considered.

The Principals are requested to verify the examination forms and eligibility of the candidates and forward the same to the Controller of Examinations, Palamuru University by **18-02-2017** positively, along with the Nominal Roll (in duplicate) Fee abstract statement required about the payment of Examination Fee.

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

The University has decided to accept the payment of examination fee through core banking system from the colleges under palamuru Univeristy jurisdiction.

The concerned Principal's are requested to deposit (credit)/transfer the Consolidated Examination fee amount into "Registrar, Palamuru University Examination fee Fund A/c No: **62078258948 (SBH, Raichur Road Branch, Mahabubnagar IFSCode "SBHY0020982")** in any branch of State Bank of Hyderabad through NEFT/RTGS and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms. No Demand Drafts are accepted at core banking section at Exam Branch.

Further after remitting the Examination fee into Registrar, Examination Fee Fund Account through Core Banking system the College can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examination Forms.

The College is required to enclose the clearance certificate issued by the stores section of the Examination Branch as a proof for the unused examination stationery returned by the college pertaining to the examinations conducted earlier.

The candidates appearing for B.Ed. III Semester Examinations are advised to enclose the xerox copies of B.Ed. I&II Semester Memo of Marks.

Fee paid once cannot be refunded or adjusted for any future examination.

ALL THE COLLEGE PRINCIPALS ARE REQUESTED TO SEE THAT THE PREPARATION OF EAF ONLINE WITHOUT LATE FEE ON OR BEFORE 18-02-2017. IF EAF IS PREPARED AFTER 18-02-2017 THE LATE FEE WILL BE IMPOSED AUTOMATICALLY BY ONLINE FEE STRUCTURE.
