- a) Exam application forms duly signed by the student and the Principal concerned along with photocopy of qualifying examination should be submitted to the examination branch before **08-06-2018**. The delay in submission after the last date will attract penalty (**Rs.1000/-**). Xerox copies of Examination application forms & photographs will not be considered.
- b) Students are hereby informed that they should enclose their previous examination Memorandum of Marks/Hall Ticket attested by the College Principal concerned with the Examination Application forms.
- c) Not to collect the Exam fee only (Collect only Memo fee Rs.60/-) from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

- d) Payment of examination fee & submission of application forms will not be entertained after the due date under any circumstances. The Examination fee once paid by the candidate will not be refunded or adjusted.
- e) Principals of all B.P.Ed. colleges are informed that they should not direct the students to the Examination Branch, P.U. for late fee, otherwise disciplinary action will be initiated.
- f) The University has decided to accept the payment of Examination fee through Core Banking System from the Colleges under Palamuru University Jurisdiction under any circumstances Demand drafts will not be accepted.
- g) **It is required to TRANSFER (Cash deposits/Challans are not accepted) the fee amount through RTGS/NEFT for credit into Registrar, Palamuru University Exam Fee Fund A/c No. 62078258948 (SBI, Raichur Road Branch, Mahabubnagar, IFSC Code "SBIN0020982").**
- h) The principals are requested to verify the application forms and forward them immediately along with the Name List (Nominal Roll) in the prescribed Proforma, subjectwise data & fee particulars in duplicate to the exam branch.
- i) Last date for submission of application forms & nominal rolls is **08-06-2018**.

1. *The candidates of 2015-16 batch who have completed Semester-IV examination are eligible to appear for the subject wise improvement of Semester-IV.*
2. *The candidates of 2016-17 batch who have completed Semester-II examination are eligible to appear for the subject wise improvement of Semester-II.*
3. *The hall ticket numbers of NOT ELIGIBLE STUDENT(S) will be deleted/removed from result process at any time, even if the hall ticket is issued.*
