**B.P.Ed. SEMESTER-I (REGULAR/BACKLOG) EXAMINATIONS, DEC.-2019**

It is hereby notified to all candidates of **B.P.Ed.** of Affiliated colleges of Palamuru University that the **I - Semester (Regular/Backlog) Examinations are scheduled in the month of January, 2020.** The detailed Time-Table will be notified in due course.

**Candidates belonging to the academic year 2013-14 and prior to this academic year should not apply for any of their backlog paper(s).**

Further, it is informed that the candidates of **B.P.Ed.** who were admitted during the Academic year **2014-15 & 2015-16 (i.e., 2014 Batch & 2015 Batch),** have to pay **Rs. 1000/-** for each backlog paper in addition to normal examination fee.

This is the last chance for the candidates admitted during the Academic Year 2014-2015 & 2015-2016 to appear for the backlog examinations.

**SPECIAL INSTRUCTIONS TO THE PRINCIPALS:-**

- I. The late fee amount will be levied automatically in case the fee is not remitted to the P.U. A/c and forms are not submitted as per the above schedule.
- II. Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.
- III. All the principals are requested to submit Semester-I (Regular/Backlog) consolidated internal assessment marks and practical marks hard copy to the examination branch.
- IV. Fee Paid once cannot be refunded or adjusted.

**GENERAL CONDITIONS TO THE PRINCIPALS:**

1. The Examination Application Forms are to be submitted to the Examination Branch duly signed by the student and the principal concerned along with a photocopy of qualifying examination. Xerox copies of Examination Application Forms will not be considered.
2. A Penal fee of Rs.1,000/- per day shall be levied if the college fails to submit the Examination application forms within the stipulated date **10-01-2020** along with the Name List, Fee Particulars & Subject wise data in duplicate.
3. **The College will be held responsible for any mistake committed while filling the Candidate name, mother name, father name and paper title (Theory & Practical). IN CASE OF ANY MISTAKE RS. 500/- will be levied as FINE for rectification of each error.**
4. Not to collect the Exam fee except Memo fee Rs.65/- + Processing fee Rs.330 from Blind, Physically differently abled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Their Application forms and nominal rolls should be submitted separately.
5. The concerned Principal's required to **TRANSFER** (Cash deposits/Challans are not accepted) the fee amount through RTGS / NEFT for credit into Registrar, Palamuru University Exam Fee Fund A/c No **62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSC Code "SBIN0016375")**.
6. Inform all the concerned candidates that the payment of examination fee & submission of application forms will not be entertained after the due date under any circumstances.
7. **It is informed to all the principals of all B.P.Ed. colleges that not to direct students to the Examination Branch, P.U for late fee.**

8. Fresh candidates appearing for I-Semester shall enclose Xerox copies of their qualifying Degree Certificates (i.e. Memorandum of Marks, Provisional & Convocation certificates), duly attested by the Principal of College concerned. Other than Palamuru University candidates should enclose their Original Migration Certificate along with a fee of Rs.125/- in addition to the examination fee.
