### GENERAL CONDITIONS TO THE PRINCIPALS: -

1. The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of qualifying examination.
2. The Principals are requested to verify and forward all the ONLINE APPLICATION FORMS immediately along with the Name List (Nominal Roll) in prescribed Performa, subject-wise data & fee particulars in duplicate.
3. The Principals are requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fees for unreceived

application forms are not refundable. Individual demand drafts submitted by the students will not be accepted.

4. **Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.**
5. The Principals are requested to verify and forward all the ONLINE APPLICATION FORMS immediately along with the Name List (Nominal Roll) in prescribed Performa, subject-wise data & fee particulars in duplicate.
6. The college login will be closed after the last date.
7. The Principals are requested to submit the Internals award lists of B.Ed. IV-Semester Online only. The copy of same (Internal awards) with Principal Attestation should be submitted to the Addl. Controller of Examinations (P-II), P.U. The date will be announced later.
8. The College Principals are requested to submit the list of Faculty members working in your college, their service Particular, Subjects Teaching and Cell Phone Number without fail.

**IMPROTANT NOTE:**

- (i) As a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their respective College Principal's Accounts only (students are advised not to obtain the DD in favour of the "Controller of Examinations", PU)
- (ii) The concerned Principal's required to transfer the fee amount through RTGS / NEFT for credit into **Registrar Palamuru University Exam Fee Fund A/c No. 62078258948 (SBH, Raichur Road Branch, Mahabubnagar IFSC Code "SBHY0020982")**, and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms. No Demand Drafts are accepted at core banking section at Exam Branch.
9. **ALL THE COLLEGE PRINCIPALS ARE REQUESTED TO SEE THAT THE PREPARATION OF EAF ONLINE WITHOUT LATE FEE ON OR BEFORE 01-08-2017. IF EAF IS PREPARED AFTER 01-08-2017 THE LATE FEE WILL BE IMPOSED AUTOMATICALLY BY ONLINE FEE STRUCTURE.**
10. No Examination Application form will be entertained after the due date **05-08-2017**.
11. The Colleges are required to enclose the clearance certificates issued by the stores section of the Examination Branch as a proof for the unused examination stationery returned by the college pertaining to the examinations conducted earlier.
12. Principals of the colleges are requested to submit the Application forms at the earliest possible date without waiting for the cutoff date and furnish the details in the given performs.
13. The Backlog candidates are advised to enclose the Xerox copies of their latest Memorandum mark memo. All the 4th semester candidates have to submit Xerox copies of I, II, and III Semester Memos.
