**Examination fee Details**

**B.P.Ed. Semester-III:** Fee is Rs.1040/- + Rs.60/- (Memo charges)= Total fee is *Rs.1100/-*

**B.P.Ed. Semester-I:** Fee is Rs.1040/- + Rs.60/- (Memo charges)+Rs.300 (Processing Fee) = Total fee is Rs.1400/-.

- a) Students are hereby informed to enclose their previous examination Memorandum of Marks/Hall Ticket attested by the College Principal concerned with the Examination Application forms.
- b) Not to collect the Exam fee only (Collect only Memo fee Rs.60/-) from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.
- c) Inform all the concerned candidates that the payment of examination fee & submission of application forms will not be entertained after the due date under any circumstances. The Examination fee once paid by the candidate will not be refunded or adjusted.

- d) It is informed to the principals of all B.P.Ed colleges that not to direct students to the Examination Branch, P.U for late fee, otherwise disciplinary action will be initiated.
- e) Instruct the students to enclose the Xerox copies of the memorandum of marks of earlier examinations to verify eligibility.
- f) The University has decided to accept the payment of Examination fee through Core Banking System from the Colleges under Palamuru University Jurisdiction under any circumstances Demand drafts will not be accepted.
- g) **It is required to TRANSFER (Cash deposits/Challans are not accepted) the fee amount through RTGS/NEFT for credit into Registrar, Palamuru University Exam Fee Fund A/c No. 62078258948 (SBI, Raichur Road Branch, Mahabubnagar, IFSC Code "SBIN0020982").**
- h) The principal is requested to verify and forward all the application forms immediately along with the Name List (Nominal Roll) in prescribed Proforma, subjectwise data & fee particulars in duplicate.
- i) Last date for submission of application forms & nominal rolls is **06-02-2018**.
