GENERAL CONDITIONS TO THE PRINCIPALS: -

1. Exam application forms duly signed by the student and the Principal concerned along with photocopy of qualifying examination should be submitted to the examination branch before the last date. The delay in submission after the last date will attract penalty (**Rs. 1000/-**) Xerox copies of Examination application forms & photographs will not be considered.
2. The Principal is requested to pay the examination fee for received application forms only. Any excess fees for un-received application forms are not refundable.

3. The principal is requested to verify and forward all the application forms immediately along with the Name List (Nominal Roll) in prescribed Proforma, subject wise data & fee particulars in duplicate.
4. The Principals are requested to submit **COMPULSORY** the following documents, otherwise their forms will not be accepted.
 - 1) The detailed fee statement signed by the college Principal.
 - 2) Proforma of Paper wise strength particulars signed by the Principal.
 - 4) The list of admitted I-Semester candidates for the year 2018-2019 signed by the Director, Pharmacy Admission, P.U.
 - 5) No Dues Certificate and Affiliation extension order for the year 2018-2019 with sanctioned strength issued by the Academic Branch, P.U.
 - 6) The Clearance certificate from the Director, Directorate of Academic Audit, P.U. certificate
5. **Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.**
6. As a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their respective College Principal's Accounts only (students are advised not to obtain the DD in favour of the "Controller of Examinations", PU)
7. The concerned Principals are required to transfer the fee amount through RTGS / NEFT for credit into **Registrar Palamuru University Exam Fee Fund A/c No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar IFSCCode "SBIN0016375")** and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms. No Demand Drafts are accepted at core banking section at Exam Branch.
8. Last date for submission of application forms & nominal rolls along with payment fee details to the Controller of Examinations, PU is **13-11-2018**.
