GENERAL CONDITIONS TO THE PRINCIPALS: -

- a)** Exam application forms of students belonging to M.Pharm. I-III, duly signed by the student and the Principal of the concerned college along with photocopy of qualifying examination should be submitted to the examination branch before the last date. The delay in submission after the last date will attract penalty **Rs. 1000/-** Xerox copy of photograph will not be considered.
- b)** Application forms of students belonging to M.Pharmacy IV semester should be accompanied with all the memos of previous semesters (i. e I-III semesters)

2. The Principal is requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fee for un-received application forms are not refundable.
3. The principal is requested to verify and forward all the application forms of the students along with the Name List (Nominal Roll) in prescribed Proforma, subject wise & fee particulars in duplicate.
4. The Principals are requested to forward all the **Project Report of the students** who have registered for IV-Semester Examination duly certified by the supervisor and principal of the college along with Two copies of Nominal Rolls and "ONE COPY" of the Project report of each student on or before **20.06.2020** keeping the other 3 copies in the college, which should be produced at the time of Viva-Voce for the use of Examiner(s) deputed for conducting the Viva-Voce Examination on the specified date(s) as per Almanac. **Those candidates who do not register for the IV-Semester Examination will not be considered for taking the Examinations. The Principals are requested to contact the Controller of Examination for their final Viva-Voce.**
5. **Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. These Application forms should be submitted separately along with Separate Nominal Roll.**
6. All the students are hereby instructed to deposit Examination fee into their respective College Principal's Accounts only (students are advised not to obtain the DD in favour of the "Controller of Examinations", PU)
7. The concerned Principal's are requested to transfer the fee amount through RTGS / NEFT for credit into **Registrar, Palamuru University Exam Fee Fund A/c No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSCode "SBIN0016375")** and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms. No Demand Drafts are accepted at Exam Branch.
