### DETAILS OF EXAMINATION FEE

Examination fee is Rs.800/- + Memorandum of marks is Rs.60/- .

For consolidated memo Rs.350/-+ Rs.60/- For Provisional certificate.

Candidates have to submit their duly completed application forms in all respects at the office of the Principal of the concerned college.

### GENERAL CONDITIONS TO THE PRINCIPALS: -

1. Exam application forms duly signed by the student and the Principal concerned along with photocopy of qualifying examination should be submitted to the examination branch before the last date. The delay in submission after the last date will attract penalty **Rs. 1000/-** Xerox copies of Examination application forms & photographs will not be considered.

2. The Principal is requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fee for un-received application forms are not refundable.
3. The principal is requested to verify and forward all the application forms immediately along with the Name List (Nominal Roll) in prescribed Proforma, subject wise & fee particulars in duplicate.
4. The principals are requested to forward all the **Project Title of the students** who have registered for IV-Semester Examination duly certified, along with Two copies of Nominal Roll and “ONE COPY” of the Project title of each student on or before **09.04.2018** keeping the other copy in the college, which should be produced at the time of Viva-Voce for the use of Examiner(s) deputed for conducting the Viva-Voce Examination on the specified date(s). **Those candidates who do not register for the IV-Semester Examination will not be Considered for taking the Examinations. The Principals are requested to contact the Head of the Department concerned for their Viva-Voce.**
5. **Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.**
6. As a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their respective College Principal's Accounts only (students are advised not to obtain the DD in favour of the “Controller of Examinations”, PU)
7. The concerned Principal's required to transfer the fee amount through RTGS / NEFT for credit into **Registrar Palamuru University Exam Fee Fund A/c No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar IFSC Code “SBIN0016375”)** and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms. No Demand Drafts are accepted at core banking section at Exam Branch.
8. Last date for submission of application forms & nominal rolls along with payment fee details to the Controller of Examinations, PU is **10-04-2018**.
