GENERAL CONDITIONS:

1. All the candidates who have completed their Course work in their respective subject (s) are eligible to appear for Ph.D Course Work Examination.
2. All the candidates who are appearing for the above said examination have to enclose photocopy of the Qualifying Examination Degree Certificate and Joining Report. The candidates other than Palamuru University have to submit the Migration certificate in original along with application form.
3. Examination application forms duly signed by the Candidates, Supervisor, Head and the Principal concerned should reach the examination branch before the last date from the Principal office. The delay in submission after the last date will attract penalty of **Rs. 1000/-**. Xerox copies of Examination application forms & photographs will not be considered.

4. The Principal is requested to pay the examination fee for received application forms only. Any excess fee is not refundable.
5. The Principal is requested to verify and forward all the application forms immediately along with the following documents:
 - i. Nominal Roll
 - ii. Subject wise -Titles of Paper-II (Specialization paper).
 - iii. Consolidated fee Statement.
6. As a part of the CORE BANKING SYSTEM, all the students are hereby instructed to deposit Examination fee into their respective College Principal's Account only **(Students are advised not to obtain the DD in favour of the "Controller of Examinations", PU)**
7. The concerned Principals are required to transfer the fee amount through RTGS/ NEFT into **"Registrar Palamuru University Exam Fee Fund A/C No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar IFSC Code "SBIN0016375")** and obtain a receipt from the bank and submit the same to the Examination Branch, P.U along with application forms.
8. Last date for submission of application forms & nominal rolls along with Fee receipts to the Controller of Examinations, P.U is **15-10-2018**.
