2. No action will be taken unless this is accompanied with a photo stat copy of the Memorandum of marks
3. The prescribed fee for Revaluation/Recounting is **Rs.300/- per paper**
4. The concerned Principal's required to **transfer the fee** amount through RTGS / NEFT for credit into **"THE REGISTRAR, PALAMURU UNIVERSITY, MAHABUBNAGAR"** A/C NO: **62078258948, State Bank of India (SBI), Ganesh Nagar, Mahabubnagar, IFSC Code: SBIN0016375** and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with application forms.
