

TENDER-CUM-CONDITIONS FOR PURCHASE OF USED MAIN ANSWER SCRIPTS

1. The rates for the used main Answer scripts should be quoted for **100 kgs** only.
2. The basis price for the used main answer scripts is fixed at **Rs.2150/- per 100 Kgs**.
3. This condition sheet should be signed by the Tenderer and attached to the tender, failing which; the tender will not be accepted.
4. Tender-cum-Application Forms can be had from the Controller of Examination, Palamuru Univeristy on payment of Rs.2000/- by DD in favour of the **Registrar, Exam fee Fund A/C Palamuru Univeristy** from any Nationalized Bank from **24-09-2016 to 03-10-2016** (up to 2.00 p.m) Tender Forms can also be downloaded from Palamuru Univeristy website **www.palamuruuniversity.com** if the downloaded tender application form is used, a **DD Rs.2000/-** drawn in favour of the Registrar, Exam fee Fund A/C Palamuru Univeristy on any Nationalized Bank should be enclosed while submission.
5. The paper sample can be inspected between 12.00 noon to 3.00 p.m on **1st October, 2016**.
6. All intending tenders should enclose a crossed Demand Draft on any Nationalized Bank drawn in favour of the Registrar, Exam Fee fund A/C, Palamuru Univeristy, Mahabubnagar for Rs.1.00 lakh as earnest Money deposit (EMD), without Earnest Money Deposit DD the tender will not be considered.
7. Tender should be sent in a sealed envelope, addressed to Registrar, Palamuru University, Mahabubnagar-509 001 superscribed as “Tender for used Answer Scripts & Confidential” and this should reach the Registrar, before 3.00 p.m on 05-10-2016 and will be opened at 4.00 p.m on the same day in the premises of Examination Branch, Palamuru Univeristy, in the presence of such of the Tender or their representatives who would be present.
8. The Univeristy reserves the right to reject any or all tenders and cancel the sale without assigning any reason.
9. The successful Tenderer has to lift the entire stock within a 15 days night from the date of intimation of acceptance of the tender. Further, the material should be lifted during the office hours only.
10. The lifting of material will be permitted only on prior payment of cost by Demand Draft on any Nationalized Bank, drawn In favor of “**The registrar, Exam fee fund A/C, Palamuru Univeristy**.”
11. The delivery of the material will be made at the NTR Govt. Degree College and near Palamuru University, Administrative Office, Raichur Road, Bandameedipally, Mahabubnagar. The transportation and weighing expenses will be borne by the successful Tenderer.
12. The successful Tenderer violating any of the above conditions will not only forfeit his earnest money deposit of Rs.1.00 Lakh but also is liable to make goods all the losses to the Univeristy accruing on account of failure to discharge the obligations of the tender.
