**SPECIAL INSTRUCTIONS TO THE PRINCIPALS**

- ❖ The college login will be closed after the last date as mentioned above.
- ❖ The late fee will be levied automatically in case the fee is not remitted to the P.U. A/c.
- ❖ Late Fees will be levied, if online EAFs are not submitted on or before due date, even if Fees remitted into fund account within due date.
- ❖ Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, even if they appear for the examinations.
- ❖ The Principals are requested to transfer Consolidated exam fee amount into “**Registrar Palamuru University, Exam Fee Fund A/c No: 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar IFS Code “SBIN0016375”)** through NEFT/RTGS only.

**Note:**

1. The details of Examination Fee schedule is enclosed.
2. The Examination application forms of all students are to be submitted online through college login. Also, hard copy of the same may be downloaded and submitted to the examination branch duly signed by the Student and the Principal concerned along with photocopy of Memo.

3. The candidates who are appearing for the examinations under the notification have to pay an amount of Rs.1000/- per paper, along with normal examination fee.
4. All the candidates of all Batches who have backlog of **English Paper- I & Paper- II** have to appear for the Viva- Voce, CBT and Theory Examination.
5. The exact date of commencement of the examinations and detailed time – table will be notified later.
6. Each Practical paper, IHC, Environmental Studies, Science & Civilisation, Computer Skills I&II and Human Values & Professional Ethics are treated as separate papers. The Candidate has to pay the examination fee and register for the examination.

**7. The Principals of the Under–Graduate colleges are requested to:**

- a) Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.
  - b) **Not to forward the application forms of the candidates admitted during the academic year 2009 - 2010 and earlier.**
  - c) Inform all the concerned candidates that the payment of examination fee & submission of application forms will not be entertained after the due date **under any circumstances**. The Examination fee once paid by the candidate will not be refunded or adjusted.
  - d) Instruct the students to enclose the Xerox copies of the memorandum of marks of earlier examinations to verify eligibility.
  - e) In case of the candidates transferred from other Universities and autonomous colleges a new HT number which is not allotted earlier to any of the candidate of the college has to be allotted and enclose the PU Admission/Permission orders for transfer, memorandum of marks, and migration certificate of the parent University.
9. The University has decided to accept the payment of Examination fee through Core Banking System from the Colleges under Palamuru University Jurisdiction under no circumstances Demand drafts will be accepted.  
It is required to transfer the fee amount through RTGS / NEFT for credit into **Registrar, Palamuru University, Exam Fee Fund A/c No. 62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSC Code “SBIN0016375”)**.

**Submit all the Application forms along with the:**

1. Consolidated fee receipt obtained from the SBI Bank may be submitted to the Examination Branch Section, Examination Branch, P.U, where Receipts Pertaining to B.A/B.Com/B.Sc will be issued separately. (In no case individual receipts Submitted by students will be accepted).
2. Nominal Rolls (Only one copy): One hard copy of nominal rolls (consolidated list of candidates 2010-11 batch) generated using the Students online information System after due verification and signed by the Principal.

3. Subject-wise Data & Elective Papers Data of registered candidates in the prescribed proforma, must match with that of the applications submitted.
4. List of Transferred Candidates
  - i. Transferred from one college to another college of Palamuru University.
  - ii. Transferred from other Universities.
5. List of Physically handicapped and Deaf & Dumb Candidates.
6. **Fees Abstract :**  
(in duplicate) one hard copy of the Fee Abstract Prepared/downloaded using the link provided at College Login.
