SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- ❖ The college login will be closed after the last date as mentioned above.
- ❖ The late fee will be levied automatically in case the fee is not remitted to the P.U. A/c.
- ❖ Late Fees will be levied, if online EAFs are not submitted on or before due date, even if fees remitted into fund account within due date.
- ❖ Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, even if they appear for the examinations.
- ❖ The Principles are requested to transfer Consolidated exam fee amount into Registrar Palamuru University Exam Fee Fund A/c No **62078258948 (SBI, Raichur Road Branch, Mahabubnagar, IFSC Code "SBIN0020982")**, through NEFT/RTGS only.
- ❖ It is informed to the principals of all UG colleges that not to direct students to the Examination Branch, P.U for late fee, otherwise disciplinary action will be initiated.
- ❖ Application forms without late and with late fee of **Rs.200/-** with all the above requirements should reach the Examination Branch, PU, on or before **20-09-2018**. Application forms with a late fee of **Rs.500/-** should reach the examination branch on or before **28-09-2018**. A penal fee @ **Rs.1,000/-** per faculty will be collected per day from the college on applications received after the above dates.

Note:

1. The details of Examination fee schedule is enclosed.
2. The Examination application forms of **ALL** students (All batches) are to be submitted **online through college login**. Also, hard copy of the same may be downloaded and submitted to the examination branch duly signed by the Student and the Principal concerned along with photocopy of Memo.
3. The candidates who have appeared for III year in double the duration of the course but not crossed (8) years from the date of admission and intended to write **backlog papers**, have to pay an amount of **Rs.1000/- per paper**, along with normal examination fee i.e. candidates admitted during the academic year 2011-12 & 2012-13.
4. Whenever the syllabus changes, two more examinations i.e. one in the following September and the other in the following March shall be conducted according to old syllabus/regulations. Candidates not appearing in these examinations or failing in them shall take the examinations subsequently according to the changed syllabus/regulations.
5. All the candidates of all Batches who are writing **English Paper-I & Paper-II** have to appear for the Viva- Voce, CBT and Theory Examination.
6. The exact date of commencement of the examinations and detailed time-table will be notified later.
7. Each Practical paper, IHC, Environmental Studies, Science & Civilization, Computer Skills I & II and Human Values & Professional Ethics are treated as separate papers. The Candidate has to pay the examination fee and register for the examination.
8. The Principals of the Under-Graduate colleges are requested to:
 - a) **Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students.** A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. **Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.**
 - b) Inform all the concerned candidates that the payment of examination fee & submission of application forms will not be entertained after the due date **under any circumstances**. The Examination fee once paid by the candidate will not be refunded or adjusted.
 - c) Instruct the students to enclose the Xerox copies of the memorandum of marks of earlier examinations to verify eligibility.
 - d) In case of the candidates transferred from other Universities and autonomous colleges a new HT number which is not allotted earlier to any of the candidate of the college has to be allotted and enclose the PU Admission/Permission orders for transfer, memorandum of marks and migration certificate of the parent University.
9. The University has decided to accept the payment of Examination fee through **Core Banking System** from the Colleges under Palamuru University Jurisdiction **under any circumstances Demand drafts will not be accepted**.
10. It is required to **TRANSFER** (*Cash deposits/Challans are not accepted*) the fee amount through RTGS / NEFT for credit into **Registrar, Palamuru University Exam Fee Fund A/c No 62078258948 (SBI, Raichur Road Branch, Mahabubnagar, IFSC Code "SBIN0020982")**.
11. Submit all the Application forms along with the
 - i. **Consolidated fee receipt** obtained from the Bank for having transferred the amount through NEFT/RTGS may be submitted to the Examination Branch, P.U, Where receipts pertaining to **B.A/B.Com/B.Sc** will be issued separately (*In no case individual receipts/DD's submitted by students will be accepted*).

- II. **Nominal Rolls (Only one copy):** One hard copy of nominal rolls (consolidated list of candidates) generated using the Students **online information System** after due verification and signed by the Principal.
- III. **Subject-wise Data & Elective Papers Data** of registered candidates in the prescribed proforma, which must match with that of the applications submitted.
- IV. **List of Transferred Candidates: -**
 - Transferred from one college to another college of Palamuru University.
 - Transferred from other Universities.
- V. **List of Physically handicapped and Deaf & Dumb Candidates.**
- VI. **Fees Abstract (in duplicate) one hard copy of the Fee Abstract Prepared / downloaded using the link provided at College Login.**

12. **Eligibility for Improvement**

- a. Candidates, who appeared and passed their III year in one attempt in April 2018, are alone eligible to appear for improvement in one or more papers of III year respectively.
- b. For improvement of division under part-II the candidate has to either appear for all the papers of III year including Practicals or any number of optional papers of I and II year (who have not availed improvement chances earlier) along with all III year papers (compulsory) also.
