2. Action will not be taken unless the application is accompanied with a photocopy of the memorandum of marks.
3. The prescribed fee for Recounting is **Rs.300/- per paper**.
4. The concerned Principal is required to **transfer the fee** amount through RTGS / NEFT for credit into **"THE REGISTRAR, PALAMURU UNIVERSITY, MAHABUBNAGAR"** A/C No: **62078258948, State Bank of India (S.B.I.), Ganesh Nagar, Mahabubnagar, IFSC Code: SBIN0016375** and obtain a receipt from the bank and submit the same to the Examination Branch, PU along with the application forms.
