2. The submission of application(s) after the last date will attract a penalty of **Rs. 1000/- per day**. Xerox copies of Examination application forms & photographs will not be considered.

3. The Principals are requested to pay the examination fee for received application forms and not to pay the fee for un-received application forms. Any excess fees for un-received application forms are not refundable.

The principal is requested to verify and forward all the application forms immediately along with the Name List (Nominal Roll) in prescribed Proforma, (Consisting name, Father's & Mother's name, Gender, Category and the theory and practical papers registered for the exam) subject wise, fee particulars.
