3. The prescribed fee for Revaluation/Recounting is **Rs.300/- per paper**
4. The concerned Principal's required to **transfer the fee** amount through RTGS / NEFT for credit into **"THE REGISTRAR, PALAMURU UNIVERSITY, MAHABUBNAGAR"**
