SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- ❖ The college login will be closed after the last date as mentioned above.
- ❖ The late fee will be levied automatically in case the fee is not remitted to the Exam Fee Fund A/c, P.U.
- ❖ Late fees will be levied, if online EAFs are not submitted on or before the due date, even

- if fees remitted into fund account within due date.
- ❖ Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of not eligible candidates will be cancelled at any stage, even if they appear for the examinations.
 - ❖ Principals of all B.Ed. colleges are informed to not to direct students to the Examination Branch, P.U for late fee, otherwise disciplinary action will be initiated.
 - ❖ Application forms with and without late fee with all the above requirements should reach the Examination Branch, P.U, on or before **16-07-2025**. A penal fee @ **Rs.1,000/-** per faculty will be collected per day from the college on applications received after the above dates.

Important Note:

1. The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of qualifying examination (user manual is enclosed). Xerox Copies of Examination Application Forms & photographs will not be considered.
2. The Principals are requested to transfer consolidated exam fee amount into Registrar, Palamuru University, Exam Fee Fund A/c No **62078258948 (SBI, Ganesh Nagar Branch, Mahabubnagar, IFSC Code "SBIN0016375")**, through NEFT/RTGS only.
3. The Examination application forms are to be submitted **online through college login**. Also, hard copy of the **same may be downloaded and submitted to the examination branch duly signed by the student and the Principal concerned along with photocopy of memo**.
4. The exact date of commencement of the examinations and detailed time- table will be notified later.
